

Fall 2021 Book List – All Courses

The Higher Education Opportunity Act requires schools to provide the publisher's suggested retail price (PSRP) for new textbooks, but UDC Law does not require students to purchase new textbooks. Students may buy used books, borrow, rent, etc., as long as they are able to get the required edition of each book. Students should not purchase digital versions (e-books) unless expressly permitted by the professor.

FOLLETT ALL ACCESS: Follett All ACCESS is a program under which the UDC Campus Bookstore delivers all required textbooks for a single per-semester fee that is charged to a student's account. **All UDC students are automatically enrolled in the Follett All ACCESS program each semester.** The fee is \$34 times a student's total semester credit hours (e.g. \$34 x 12 credit hours) regardless of the number or market prices of books required. If the required edition of a book exists in digital format (as an e-book), students will receive a digital version only.

This program is intended to save students money and time securing books, but students are encouraged to 'do the math' based on the books required for their courses each semester. Students may **opt out** of the program completely (no partial opt-outs) by each semester's opt-out deadline. Those who opt out of the program must buy their required books individually. If the UDC Bookstore provides the digital version of a book and the professor requires students to use a paper book (i.e. no e-book allowed), students will need to buy the paper version separately. That added cost should be factored into each student's decision to remain in or opt out of Follett All ACCESS.
